## ORDER

The Court gives ALL necessary power, without need of motioning the Court, to the Receiver to make decisions and achieve the election of Directors immediately.

- 1. Election Buddy shall send out ballots by mail.
- 2. Election Buddy shall secure nominations for Directors.
- 3. Fields' Defendants shall provide voting list to Receiver within 20 days. If this matter comes before the Court again, incarceration shall be the punishment for any contempt found by the Court.
- 4. The concerns regarding an accurate list of owners who have paid dues will always be a concern, but the election must proceed. Property ownership data is not private. Land ownership is public information and there is no harm as to its publication. Email and phone numbers are private and shall only be listed for those asking to be nominated as Directors. Deerfield accounts shall not be uploaded. They shall be made available for inspection upon request.
- 5. Fields' Defendants shall provide a management contract to Receiver within 20 days. If this matter comes before the Court again, incarceration shall be the punishment for any contempt found by the Court.

- 6. Within 20 days, Mr. Hurley shall provide Receiver with all past due fees held by him on behalf of his clients. If this matter comes before the Court again, incarceration shall be the punishment for any contempt found by the Court.
- 7. The Court can give no guidance to Receiver regarding the golf course as the controversy is not before the Court and advisory opinions are not allowed.
