Note: Field Development Company owns a total of 17 parcels in Deerfield Resort, including 2 parcels that are common areas (1.87 acres); and mineral, oil, and gas rights for 658.7 acres of Deerfield Resort lots. With the removal of the common area lots to be transferred to the Deerfield Resort HOA and the mineral, oil, and gas rights, FDC owns 14 parcel – two of which are too small to build on (.09 and .05 acres). Total acres owned minus common areas to be transferred to the HOA, and mineral, oil and gas rights, 41.50 acres.
